LINCOLN PARISH LIBRARY BOARD OF CONTROL Minutes of Meeting July 13, 2022

The Lincoln Parish Library Board of Control Meeting was called to order at 4:00 pm by Amy Miller. Board members present included Mary Jo Cooper, Sandra Dupree, Richard Durrett, Bill Jones, Amy Miller, Diana Humphries, Eric McCulloch, and Deborah Gilliam. Absent from the meeting was Jan Canterbury.
